# ANNUAL MEETINGS

As all know the 2015 Annual Meeting on Saturday April 25<sup>th</sup>, did not achieve a quorum, or enough owners submitting their proxies to hold an official meeting according to the bylaws. A "Q & A" forum was held in lieu of a meeting.

Per the Kahana Ridge bylaws, another meeting had to be held. In order to comply with the bylaws, a reconvened second Annual Meeting was held August 12, 2015 at the Lahaina Civic Center at 5 P.M. Again, the Association failed to attain a quorum of more than 50% of the owners either submitting proxies or present in person.

A **Board Meeting** of the current Board members was held after the failed reconvened meeting and according to the bylaws the current Board will remain in office until the next Annual Meeting on April 16, 2016. Jeff Swanson declined the Secretarial position for the remainder of his term due to other obligations. Richard Manthei was appointed and approved by the Board to replace Jeff as our Secretary.

#### **RESIGNATION OF BOARD MEMBER**

#### STREET ASPHALT SEAL COATING PROJECT- PROCEDURES

By a voice vote survey of the owners present at the April 25, 2015 informational forum, seal coating of the subdivision streets was approved with no change to speed bumps. The exact dates, will be announced soon. Work will be done during the day and during the week, not weekends, and should take no more than three days, weather permitting.

Prior to seal coating, pavement cracks will be sealed and after seal coating line repainting will be done.

Repainting of the pavement lines on Hoohui Road will also be done. Some inconveniences may occur, such as limited property access for short periods of time. You will be notified well in advance of the work. It is possible that your driveway may be temporarily blocked for a few hours to insure proper drying of the seal coat. **WARNING – DO NOT DRIVE OVER THE WET OIL.** (Your- driveway could be marked for life)

This is a threat to the County system, a violation of State Health Department regulations, and if there is a sewage spill, a U.S. EPA violation, and fines of as much as \$25,000 a day'. Please do not dispose of excess grease into the Kahana Ridge system.
